Entrants All students at Carmel College

Registration Artists legal guardian MUST also sign the entry form.

There is a \$10 non-refundable entry fee. This can be paid one of two ways:

1. Place entry fee (cash or cheque) along with completed entry form into an envelope marked "Attn: Cath Copley, ArtFusions". Ensure envelope is sealed and take to school office.
2. Email your completed registration form to artfusions.co.nz@gmail.com and pay your entry fee by direct credit to **12-3119-0111166-01**

Delivery Art must be delivered to ArtFusions Representatives at Carmel College during school hours during the last week of Term Three. We will be in touch again nearer the date with more details.

Conditions Carmel College as a Catholic School cannot exhibit art that is found offensive contradicting the moral code of the school. The art must meet the standards laid out in the detail sheets regarding packaging and quality, as the artworks are exhibited for sale. ArtFusions Staff may suggest improvements to the quality of the artworks for sale. The Student ArtFusions Curator reserves the right to exclude art from the exhibition with a refund of the \$10 registration fee if the art is deemed to be offensive or not sale-worthy.

Commission The artist is entitled to 65% of the selling price at the close of sales. Artists may stipulate the price of their art and ask one of the ArtFusions Staff for assistance with establishing this price. Artists will need to register their bank account number in which their commission will be deposited.

Collections Unsold art will need to be collected from school within one day of the close of the exhibition.
